Repairs / Service / maintenance/ calibration of VESDA System at SFF Saldanha Terminal.

During the inspection / servicing and maintenance of the fire equipment at Saldanha Terminal, by ESS Fire & Emergency services, the following defects on the VESDA system was noticed

MAIN ADMIN BUILDING:

Vesda Panel at server room Faulty due to network problem at this stage but is working. System to be upgraded to a conventional system as some of the other areas has been upgraded.

WAREHOUSE: Conventional panel with manual call points, sounder units and detectors that reports to main Panel in Control Room. System shows fault in Zone 3 and zone wiring needs to be checked.

Panel also not reporting to main Panel due to the transmitter outside being faulty and suspect that receiver outside control room also faulty. No communication between Conventional panel and main Panel. A weatherproof sounder to be located on the outside of the building.

SUBSTATION: Conventional panel with manual call points, sounder units and detectors that reports to main Panel in Control Room. Panel also not reporting to main Panel due to the transmitter outside being faulty and suspect that receiver outside control room also faulty. No communication between Conventional panel and main Panel. Substation Panel was tested and working.

FIRE PUMP HOUSE: Conventional panel with manual call points, sounder units and detectors that reports to main Panel in Control Room. The system shows faults in Zone 1 and zone wiring needs to be checked. Panel also not reporting to main Panel due to the transmitter outside being faulty and suspect that receiver outside control room also faulty. No communication between Conventional panel and main Panel. The warehouse panel was tested and working.

BOOSTER PUMP HOUSE: Conventional panel with manual call points, sounder units and detectors that reports to main Panel in Control Room. Panel also not reporting to main Panel due to the transmitter outside being faulty and suspect that receiver outside control room also faulty. No

communication between Conventional panel and main Panel. Booster Pump house panel was tested and working.

SECURITY OFFICES: Vesda System completely offline and not working. Communication and Panel fault. To be replaced with conventional panel and detector range as per other buildings.

TRAINING CENTRE: Vesda System completely offline and not working. Communication and Panel fault. To be replaced with conventional panel and detector range as per other buildings.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

ANNEXURE 5

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
