1. BACKGROUND

SFF is a wholly owned subsidiary of CEF established by the Government and came into operation in 1977. The entity is mandated by the Minister of Energy to manage and control the Strategic stocks, Strategic assets, and commercialization of the assets to fund the government mandate.

BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

BACKGROUND AND SCOPE

The Strategic Fuel Fund (SFF) Saldanha is seeking the services of a qualified consultant to conduct a comprehensive Hazard and Operability (HAZOP) study of the entire facility. This study aims to identify potential hazards, assess operational risks, and recommend mitigation measures to enhance safety, reliability, and regulatory compliance.

Objectives:

- Identify process safety hazards at the terminal by analysing current processes, existing controls, and design considerations to recommend effective measures for hazard mitigation and elimination.
- Assessing potential risks associated with crude oil storage, transfer, and handling.
- Providing recommendations for risk mitigation and system improvements
- Review of MOC documentation, maintenance records, existing controls, and any other relevant aspects.

Background:

The terminal is a storage facility consisting of two plants whereby crude oil is loaded/off-loaded at the jetty (plant 1) and is transported through two main pipelines (1067 mm and 508 mm) approximately 8.3 km to the tank farm (plant 2).

Tank farm: Six 7,500,000 barrel (approximately 1,200,000 m³) underground concrete tanks Each tank: 240 x 240 x 31 m deep

- Crude Oil Reception: Marine and pipeline receipt systems, including pumping stations and metering systems.
- Storage Systems: Underground caverns, tanks, venting systems, and associated infrastructure.
- Transfer and Distribution: Pipelines, pumps, valves, and control systems for moving crude oil within the facility.
- Loading and Export Operations: Ship loading arms, transfer lines, and associated equipment.
- Process Control & Safety Systems: Instrumentation, control rooms, emergency shutdown systems (ESD), and fire detection/suppression systems.
- Utilities and Support Systems: Electrical, water, and compressed air systems relevant to crude oil handling.

Methodology:

The study shall be conducted in line with industry best practices and applicable standards, including:

- Application of standard HAZOP guide words (e.g., No Flow, More Flow, Reverse Flow, etc.).
- Facilitation of multidisciplinary team workshops with operations, maintenance, and safety personnel.
- Risk assessment and prioritization of findings based on likelihood and consequence.
- Development of a risk register and recommendation matrix.

- Petrochemical/Chemical Engineer with minimum of 5 years in conducting HAZOP studies with a focus on process, operations and hazard management in petrochemical industry.

ANNEXURE 4

Certificate of Independent Bid Determination (SBD 9)

3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.

3.2Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or

concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
