1. BACKGROUND

SFF, a subsidiary of CEF group, owns and operates the Ogies terminal. SFF manages South Africa's inventory of crude oil and provides storage capacity for third party clients.

The SFF buildings were built a long time before there were laws regarding the use of asbestos material for piping and roof's. To comply with current building regulations, SFF are to identify all asbestos containing material in the facility so as to either replace or clean and paint according to relevant asbestos regulations.

Asbestos containing materials poses health risks. Repeated and prolonged exposure to airborne asbestos fibres, even at relatively low concentrations, can pose a serious health hazard by causing diseases such as asbestosis, lung cancer and esothelioma. Steps should therefore be taken to reduce exposure to the lowest, reasonably practicable level by either removal or cleaning of such material.

2. PERPOSE

The terminal needs to have a written inventory of the location and quantity of Asbestos Containing Materials (ACMs). This ACM's inventory stock taking is also to provide an assessment to determine if any person/s may be exposed to asbestos fibres at SFF Ogies Terminal and the facility on site . The management and control of ACMs in workplaces, buildings, plant or premises must conform, but not limited, to the Asbestos Regulations, 2001 of the Occupational Health and Safety Act (85 of 1993). This assessment is to be conducted by Approved Inspection Body.

3. SCOPE OF WORK

We require the services of a specialist vendor in the field of asbestos handling to provide an Occupational Hygiene report on:

- Inventory of Asbestos Containing Material within the SFF Ogies Terminal and site.
- Survey and Assessment of potential Asbestos exposure (Health risks) at Ogies Terminal (Asbestos Risk Assessment)
- Detailed report of the above-mentioned requirements that are in in line with all applicable and relevant asbestos regulations. The results of such a report should enable SFF to carry out repairs and cleaning required. The report will be detailing the inspection results as well as the recommended repair procedures in the format of a detailed scope of work.
